  - a. lives with "you";
  - b. is a member of "your" household;
  - c. does not otherwise attain "insured" status as defined under Definitions; and
  - d. is not a:
    - 1) guest;
    - 2) "domestic employee";
    - 3) "employee";
    - 4) tenant; or
    - 5) roomer or boarder.

With respect to Coverage C, Coverage L, and Coverage M and all of the "terms" that apply to those coverages, the definition of "insured" is also extended to a person under the age of 21 years who lives with and is in the legal custody of the person named in the Schedule. The extensions of the definition of "insured" set forth above apply only while the person named in the Schedule lives with "you" and is a member of "your" household.

- "You" and "we" agree that the coverage this endorsement provides is provided in reliance upon "your" statement that the person named in the Schedule above lives with "you" and is a member of "your" household.
- 3. "You" agree that:
  - a. if the person named in the Schedule above:
    - 1) stops living with "you"; or
    - continues to live with "you" but stops being a member of "your" household;

"you" will give "us" written notice to that effect within 30 days of the date that occurs; and

b. "you" will be solely responsible for the payment of any premium associated with this endorsement.

- 4. With respect to the coverage provided by this endorsement, item f.2) of the definition of "insured" is deleted and replaced by the following:
  - 2) persons while engaged in the employ of:
    - a) an "insured" as defined in 13.a., 13.b., 13.c., 13.d., or 13.e. under Definitions;
    - b) a person named in the Schedule above; or
    - a person under the age of 21 who lives with and is in the legal custody of a person named in the Schedule;

but only with respect to a "motorized vehicle" to which this insurance applies;

- 5. With respect to the coverage provided by this endorsement, item f.4) of the definition of "insured" is deleted and replaced by the following:
  - 4) persons or organizations accountable by law for "watercraft" or animals:
    - a) owned by:
      - (1) an "insured" as defined in 13.a., 13.b., 13.c., 13.d., or 13.e. under Definitions;
      - (2) a person named in the Schedule above; or
      - (3) a person under the age of 21 who lives with and is in the legal custody of a person named in the Schedule; and
    - b) to which this insurance applies;

but only with respect to such "watercraft" or animals.

However, this does not include persons or organizations using or having charge or control of such "watercraft" or animals in the course of "business" or without the owner's consent; or

- 6. With respect to the coverage provided by this endorsement, item f.5) of the definition of "insured" is deleted and replaced by the following:
  - 5) persons or organizations accountable by law for a motorized golf cart:
    - a) owned by:
      - (1) an "insured" as defined in 13.a., 13.b., 13.c., 13.d., or 13.e. under Definitions:
      - (2) a person named in the Schedule above; or
      - (3) a person under the age of 21 who lives with and is in the legal custody of a person named in the Schedule; and
    - b) to which this insurance applies;

but only with respect to such golf cart.

However, this does not include persons or organizations using or having charge or control of such golf cart without the owner's consent.

- With respect to the coverage provided by this endorsement, item a. under Additional Exclusions That Apply Only To Coverage L is deleted and replaced by the following:
  - a. "bodily injury" to:
    - an "insured" as defined in 13.a., 13.b., 13.c., 13.d., or 13.e. under Definitions;
    - 2) a person named in the Schedule above; or
    - a person under the age of 21 who lives with and is in the legal custody of a person named in the Schedule.
